

# **Residency Affidavit Tips**

- The custodial parent/guardian enrolling the student fills out Page 1
- The person who owns/rents the residence fills out Page 2
- Both parties sign the completed document in front of a notary
- Both pages must be notarized
- Attach the homeowner/renter's Proof of Residence to the Residency Affidavit
  - Turn in ALL pages
